Debra serves on the Board of the Garden State Council and is the Immediate Past President of the Board. She was recently named a "2024 Policy Maker" by the Executive Women of New Jersey, honoring those contributions of high-achieving New Jersey women leaders from the private and public sectors. Debra also serves on the Board of Directors of the Alice Paul Institute, and is a former Board member of the Philadelphia Diversity Law Group. Debra is a former Co-Chair and a member of the New Jersey Society of Women Environmental Professionals, where she worked within the group to promote diversity and increase the prominence of women in the environmental and energy legal, business and technical community.

In her practice, Debra concentrates in the area of complex environmental and toxic tort litigation and environmental due diligence and compliance, with an emphasis upon the defense of groundwater contamination cases involving claims for both property damage and serious personal injury.
